General Capabilities

How does OutIndex E-Discovery process native files?

1	Does the software interact with data in a forensically sound manner, ensuring there are no changes to metadata?	X	
2	Does the software check internal file signatures (not extensions) to determine file types?	X

4	Does the software insert placeholder records/images for files you are unable to process (e.g. a record in the database with the path to the file and the text "Unable to Process")?	X
